One For One supports young adults living in Chicago's most dangerous and violent communities. Our organization is about meeting the needs of the youth that we serve- providing resources and connections that have the potential to transform lives, one person at a time. Through programming, workshops, mentorship and employment, we provide opportunities that nurture values and integrity, and help individuals forge a positive future.



## **Immersive Experiences**

We provide year-round exposure workshops, career and educational programming that introduce our youth to new and exciting opportunities. Workshops are carefully planned, many with career path outcomes in mind. Our programming offers everything from field trips to cultural institutions, deep dive workshops in the arts and design, personal branding sessions, financial planning and literacy classes.

# **365 Support Services**

What separates us from others is our ability to meet the kids where they are at—providing personalized, ongoing one-on-one support throughout the year. The needs are vast and include everything from mentorship, counseling, job readiness assistance, transportation and documentation assistance, resume building, recommendation letters, college application assistance and scholarship opportunities.

## **Employment Program**

There are many barriers that prevent African American and Latinx young adults from getting jobs in Chicago. Lack of connections and limited resources often hinder opportunities for quality employment. We offer paid summer internships in our Keeping Grounded Greenhouse Program, along with a range of job placements in and around the communities we serve throughout the year.



#### **Community Impact & Support**

Community Impact & Support The impact of One For One's mission can be felt year-round, particularly on the West Side of Chicago in the Garfield Park neighborhood. Our money goes to year-round programming, workshops, exposure activities and summer employment for youth living in the most violent communities in the city. Since 2007, our organization has served more than 500 youth, caregivers and various CPS school efforts, and performed more than 1500 service hours to make sure that kids most basic needs are met. We primarily rely on the support of private funding to make our organization run and couldn't exist without the generous contributions from our sponsors and donors.
